

SCHOLARSHIP RULES FOR 2024

On behalf of the Board of Directors for the Fort Worth Association of Professional Landmen (“FWAPL”), we are excited to announce the FWAPL will offer monetary scholarships to assist qualified applicants with their tuition expenses for the 2024 fall semester. The FWAPL Scholarship Committee will accept Scholarship Applications from **June 1, 2024, through June 30, 2024. Note, Applications postmarked or timestamped June 30, 2024, will be considered timely submitted.** Thereafter, the Scholarship Committee will send an email to each applicant informing them whether or not a scholarship will be awarded to them. Each scholarship recipient will be invited to attend the FWAPL Luncheon in July, where they will be publicly recognized and presented with a check. All pertinent information regarding the eligibility requirements for all applicants, instructions for successfully completing and submitting the Scholarship Application, and important dates are discussed in detail below.

I. WHO MAY APPLY FOR A FWAPL SCHOLARSHIP?

In order to be eligible to apply for a FWAPL Scholarship, an applicant must satisfy the criteria listed in Sections 1 – 3, below.

1. The applicant must be enrolled in an accredited university or junior college for the 2024 fall semester. Applicants who are undergraduate students must be registered for courses which amount to at least six (6) credit hours. Applicants who are graduate or postgraduate students must be registered for courses which amount to at least three (3) credit hours.
2. Any one of the following statements in subsections (a) – (c) of this Section 2 is true of applicant:
 - (a) The applicant is currently, and has been for at least one (1) year immediately preceding the Scholarship Application date, an Active Member (as defined in the FWAPL Bylaws) in good standing of the FWAPL;
 - (b) The applicant is an immediate family member¹ of an Active Member described in Section 2(a) above; or

¹ “Immediate family member” shall include spouses, children, step-children, step-siblings, grandchildren, step grandchildren, and siblings of Active Members of the FWAPL.

- (c) If the applicant is neither an Active Member of the FWAPL, nor an immediate family member of an Active Member, the applicant may be eligible to apply for a FWAPL Scholarship if:
- i the applicant is a student currently pursuing a degree or certificate in Petroleum Land Management, Energy Management, Energy Commerce, or other substantially similar degree or certificate,
 - ii and is enrolled in courses for the 2024 fall semester, the majority of which are prerequisites to earning the aforementioned degrees or certificates; and the student applicant is sponsored by a current Active Member of the FWAPL.
3. The applicant must have an overall GPA of 2.5 or higher (on a 4.0 scale), as evidenced by an official transcript(s).²

II. Instructions:

Complete the FWAPL Scholarship Application form (attached) and submit (by email or physical mail to the addresses listed below) the Application, together with all attachments required therein, to the FWAPL Scholarship Committee by the June 30, 2024, deadline. Incomplete Applications will not be considered.

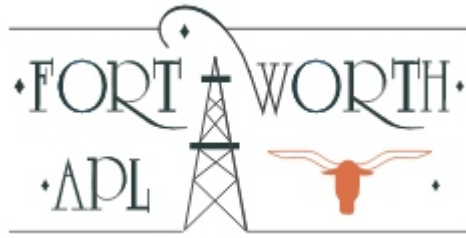

III. IMPORTANT DATES:

- Applications must be submitted by **June 30, 2024**. Applications postmarked or timestamped on June 30, 2024, will be deemed timely submitted.
- Scholarship recipients will be presented with a check at the FWAPL Luncheon in **July 2024**. If a recipient is unable to attend the Luncheon, their check will be placed in the mail no later than three (3) business days following the Luncheon.

² An applicant's high school GPA will be taken into consideration if the applicant has not completed the first semester of their freshman year at the time the application is submitted.

1. Describe your extracurricular and work activities.
2. Describe the occupation you intend to pursue upon graduation and how you plan to succeed in such occupation.
3. List your awards, honors, and achievements, and provide a brief description of each.
4. Discuss in reasonable detail, your anticipated expenses and funds available during the 2024 fall semester.
5. Based upon your history and goals, why should you be considered for the FWAPL Scholarship?

II. In a separate attachment to this Application, draft an essay covering one of the topics listed below. The essay must be between one and two single-spaced pages in length (one full page being the minimum and two pages being the maximum), typewritten in size 12 font and with 1-inch margins.

- What has been your biggest challenge so far in working towards getting a degree in your chosen field? How did you overcome it?
- Why did you choose to pursue an education in your chosen field?
- YouTube submission. Create and submit a link to a 3–5 minute YouTube video providing information about your chosen educational path that prospective students could consult to better understand the education you are pursuing and the potential career paths for an individual pursuing a similar education.
- With the recent rise of electric vehicles adoption and technology, how do you believe the oil and gas industry should adapt to help meet the world’s future energy needs?
- When talking to someone who has a negative opinion about the domestic oil and gas industry, what arguments could you use to persuade them about its benefits?
- Describe a time when you had an idea or belief challenged and how you reconciled your stance.

Essays, Transcripts, and Scholarship Forms must be postmarked or timestamped by the JUNE 30TH DEADLINE. For this Scholarship Application to be considered completed, a school/university transcript(s) of the applicant’s grades shall be provided by the applicant. At the discretion of FWAPL Scholarship Committee, candidates may also be asked to appear for an interview. Tentatively, scholarship recipients will be presented with a check at the FWAPL Luncheon in July, 2024.

For the purpose of encouraging candor, I hereby freely and voluntarily waive my right of access to any information contained on this application form and resulting evaluation from (if any) and agree said information shall remain confidential. I also agree to grant the FWAPL access to my official school/university records for the purpose of confirming accuracy of the information provided herein or attached hereto. I certify that I meet all of the eligibility requirements for applicants provided in the FWAPL Scholarship Rules for 2024, the terms of which are incorporated herein by reference, all information on this application is true and correct, and I understand that any award may be rescinded if this information is found to be false. I recognize that the FWAPL Scholarship Committee may, in its sole discretion, grant or deny a FWAPL Scholarship to qualified applicants, and all decisions made by the Scholarship Committee are final.
